regarding the selection process for "HUAWEI SEEDS FOR THE FUTURE 2024" Program

What is the purpose of this Privacy Statement (the "Statement")?

This Privacy Statement gives you information about the personal data we collect about you in relation to the selection process for the "Huawei Seeds for the Future 2024" Program, which includes the 5-day program (the "**Event**"), and how and for what purposes we process your personal data.

The "Seeds for the Future" Program, developed by Huawei, started in 2008 and is aimed at students passionate about the ICT field, and its goal is to identify young talents in the technology field and contribute to their training and professional development.

The Event includes presentations and workshops held by industry experts.

In Huawei we understand and respect the importance of privacy. This Statement describes how Huawei uses and protects your personal data while organizing the Event and how we fulfil our obligations under Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) ("GDPR").
